Original articles are accepted only on condition that they have not been published elsewhere, and will not be published elsewhere before appearance in The Journ 1. Any article that has appeared in The Journal may be reprinted elsewhere ovided proper reference to its original source is given.

on of manuscripts. Manuscripts are to be submitted in triplicate (origo carbons or photoduplicates), typewritten and double-spaced on folio $_{ra_r}$ er $8\frac{1}{2} \times 11$ inches (21 × 27 cm) with $1\frac{1}{2}$ inch margins on left, top, and .tom. Full names of all authors of each manuscript, their academic and medical regrees and administrative positions must be included with each manuscript. Most manuscripts can and should be divided into the following sections: Introduction, Materials and Methods, Results, Discussion, Summary, Acknowledgments, References, Tables, and Illustration Legends. References are to be typed on a separate page in alphabetical order according to first author and numbered consecutively with their corresponding numbers in the text. In the references full names of all authors, complete title (in original language), name of journal (names are abbreviated according to *Index Medicus*), and volume with year and first and last pages of article must be listed. Book references must have author(s) name, title of article and/or book, place and name of publisher, year of publication, and page numbers. Illustrations. Three sets are needed. Only glossy prints are accepted (photo and/or charts). The number of illustrations that can be used without charge to the author is limited to four. Illustrations in excess of this number will be charged to the author. Pictures will be reproduced only in black and white, unless authors arrange to meet the expense of color work. Each illustration must be accompanied by a short descriptive legend.

Reprints. No free separates are supplied to authors. At the time of pagination, the printer, Allen Press, will send order forms to authors, noting the number of pages, giving a table listing cost of reprints, and furnishing other pertinent information.

The International Journal of Leprosy and Other Mycobacterial Diseases is issued quarterly, one volume annually. Subscriptions are for full volume only.
